# Assessment of a Nigerian Dental School Implant Training Programme Using Short-and Long-Term Knowledge Acquisition of Students

**Objective**: To assess the effectiveness of a dental implant training programme on dental implant knowledge acquisition and retention among undergraduate dental students

Methods: A cross-sectional study of undergraduate final year students with data collected using a selfadministered questionnaire. The questionnaire elicited information on socio-demographic characteristics of the respondents, knowledge of dental implants, satisfaction and adequacy of implant education as well as interest in practicing implant dentistry. On the first day, the participants were given 20 minutes to complete the questionnaire to assess their baseline knowledge (Lo). Then a series of lectures covering various aspects of implant dentistry was delivered to the participants. At the end of the lecture series, the participants were administered the same questionnaire (L1) to assess their knowledge acquisition. Three months later, the participants were administered the same questionnaire (L<sub>2</sub>), to assess their knowledge retention. The data so obtained was analysed using IBM SPSS version 21.0. Chi square test, ANOVA and Student's T- test were performed.

**Results:** There was statistically significant difference in mean between  $L_0$  (5.53±2.816) and  $L_1$  (9.08±2.614) (3.55; p=0.001). There was increased satisfaction with the level of implant education received, level of interest and preparedness to practice implant dentistry from  $L_0$  to  $L_1$  with a decrease at  $L_2$ .

**Conclusion:** The dental implant programme which consisted of only didactic lectures is an effective method of knowledge acquisition in implant dentistry but does not translate to equal knowledge retention. Therefore, more is needed to improve dental implant training at the undergraduate level.

# INTRODUCTION

Dental implant as a form of treatment for missing teeth has become desirable (Zarb 1983a; Feine et al., 2002) due to its ability to preserve the alveolar bone and resistance to dental caries (Jivraj and Chee 2006), as well as its high success rate, predictability (Schmitt & Zarb 1993; Zarb & Schmitt 1993), increased awareness among patients (Zarb 1983a; Zarb 1983b) as well as its increased acceptance as a treatment option for

missing tooth/teeth among patients (Zarb 1983a; ADA, 2002)

Due to this increased awareness, it is essential that future dentists should be able to recognise the indications for implant treatment and provide adequate and probable treatment. Also, with the increase in use of dental implants, dental graduates may encounter more patients with dental implants in the future (Basutkar, 2013) making it imperative that they be properly exposed to this aspect of dentistry. It is very important that dental students be exposed to dental implant treatment modality as they would be providing care for partially and completely edentulous patients throughout their careers (Afshari et al., 2013).

In the United States, dental implant education is now common place within the curriculum and clinical experience of undergraduate dental students (American Association of Dental Schools, 1991). However, same cannot be said for developing countries such as Nigeria. Evidence continues to support the rationale of the advocacy for incorporation of dental implant education into the undergraduate curriculum; as dentists who are exposed to implant therapy as students are more likely to provide implant care for patients who require it (Huebner2002; Maalhagh-Fard et al., 2002; Enabulele & Omo 2018).

Appropriate didactic lectures and hands on training prior to actual patient experience have been shown to be necessary for students to be comfortable with incorporating implant treatment into their future practices (Kido et al., 2009; Enabulele & Omo 2018). This tends to allow them to see implant treatment as technically attainable and also to consider implant treatment for themselves (Kido et al., 2009; Enabulele & Omo 2018).

Throughout the course of undergraduate training at the University of Benin, students take a variety of courses where dental implants are introduced and minimally discussed. However, the students are exposed to a course that focuses solely on implant dentistry in the final year. This program includes only didactic lectures and competencies on anatomy of the edentulous patients, Biology and histology of osseointegration, Biomaterials of osseointegration, Diagnosis and treatment planning for fixed/removable implants, Selection of patients for implant dentistry, Surgical procedures for implant dentistry, Prosthodontics procedures in implant Dentistry and Periodontal aspects of implant dentistry, Implant retained over dentures and Implant complications maintenance. There was no Hands-on simulation training, phatom head component of implant dentistry or clinical experience in the restoration of implant cases and no clinical competencies assigned.

Students' perceptions of dental implant learning experiences have been thought to affect how well they learn and incorporate implant treatment options into their daily clinical practice (Yuan et al., 2010; Enabulele & Omo, 2018). Studies have shown a positive correlation between graduating dental students' intention to provide implant therapy in their future practice and their undergraduate implant education (Huebner, 2002; Maalhagh-Fard et al., 2002; Yuan et al., 2010; Kroeplin & Strub, 2011; Enabulele & Omo 2018).

A Nigerian study has shown that there is a low dental implant awareness among health workers (Mgbeokwere et al., 2011). The study further revealed that the option of restoring a lost tooth with dental implants is not included in the treatment protocols and is not frequently discussed. This emphasizes the importance of improving awareness and upgrading information about dental implant and also increases the call for a revision of the undergraduate dental curriculum in Nigeria to include dental implantology (Chaudhary et al., 2013). Furthermore, dental implant training in Nigeria is still mainly didactic competency (Enabulele & Omo, 2018). This study was designed to assess the effectiveness of a dental implant training program on dental implant knowledge acquisition and retention among undergraduate dental students.

## **MATERIALS AND METHODS**

This longitudinal study was carried out using 2 consecutive classes of final year undergraduate dental students of the University of Benin, Benin City, Nigeria. Study participation was voluntary and confidential and the participants' responses were not graded for course assessment. Ethical clearance was obtained from the College ethics and Research committee of the University of Benin

Data collection was done using a pre-tested selfadministered questionnaire. The questionnaire was developed from previous studies (Maalhagh-Fard et al., 2002; Al-Johany et al., 2010; Basutkar, 2013; Afshari et al., 2013). The questionnaire elicited information on socio-demographic characteristics of the respondents, general knowledge of dental implants, familiarity with different implant systems, designs, sizes and loading, satisfaction and adequacy of implant education as well as interest in practicing implant dentistry. Twenty questions were used to assess participants' knowledge of dental implants. All correct answers were awarded a score of 1 and zero was awarded for incorrect answers and where no answers were indicated. A pre-test of the

questionnaire was carried out among newly graduated dental students, to ascertain comprehensibility, validity, reliability and sensitivity of the data tool.

On the first day, the participants were given 20 minutes to complete the questionnaire and this was used to assess their baseline knowledge (Lo). Then a series of lectures covering: anatomy of the edentulous patients, biology and histology of osseointegration, biomaterials osseointegration, Types of implant systems, sizes, designs and loading, diagnosis and treatment planning for fixed/removable implant supported prostheses, selection of patients for implant dentistry, Single -unit implant restorations, treatment options for edentulous patients, Implant retained over dentures, surgical procedures for implant dentistry, prosthodontic procedures in implant dentistry, periodontal aspects of implant dentistry and implant complications and maintenance was delivered by a consultant restorative dentist with training on dental implants and a Consultant Periodontologist. At the end of the lecture series, the participants were asked to fill the same questionnaire (L1) in order to assess their

knowledge acquisition. Three months later, the participants who were now fresh graduates were asked to fill the same questionnaire (L<sub>2</sub>), to assess their knowledge retention. For proper collation of data, the participants were assigned codes which they indicated on the questionnaires filled on the 3 different occasions

The data so obtained was analysed using IBM SPSS version 21.0 for windows. A Chi-square test was used to compare proportions among categorical variables. Repeated measure ANOVA and Student's T- test were used to compare differences in knowledge at different times. The level of statistical significance was set at p< 0.05.

#### **RESULTS**

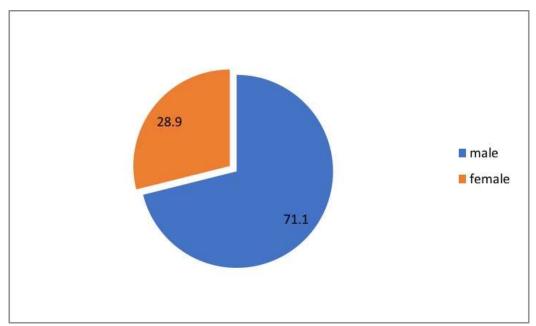


Figure 1: Gender distribution of the participants

A total of 40 students agreed to participate in the study however 38 completed all the aspects of the study ( $L_0$ ,  $L_1$  and  $L_2$ ). The age of the participants ranged from 22 to 33 years with a mean age of 26.34±2.51years. There was a male preponderance with male participants accounting for 71.1% of the study population (Figure 1). reported (Figure 3).

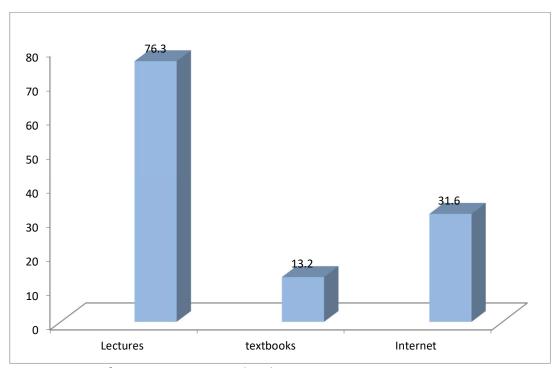


Figure 2: Sources of previous exposure to implant dentistry

Most (86.8%) of the participants had previous exposure to implant dentistry prior to commencement of the study, with undergraduate lecture accounting for the most (76.3%) source of information regarding implant dentistry (Figure 2).

Four dental specialties were reported by the participants to be their source of implant dentistry knowledge prior to the commencement of the study with periodontics being the most frequent (65.8%) specialty

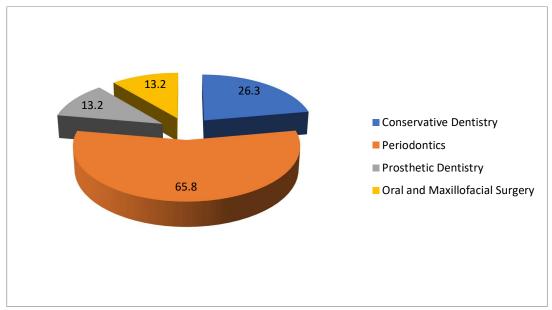


Figure 3: Specialties from which the participants were exposed to implant dentistry

The mean score  $\pm$  SD for students' general knowledge on implant was 5.53 $\pm$ 2.82 at L<sub>0</sub>, 9.08 $\pm$ 2.61 at L<sub>1</sub> and 8.68 $\pm$ 3.01 at L<sub>2</sub> (Table 1). There was statistically significant difference between the mean general knowledge score at L<sub>0</sub> and L<sub>1</sub> (3.55; p=0.001) and between L<sub>0</sub> and L<sub>2</sub> (3.16; p=0.001) The mean difference between L<sub>1</sub> and L<sub>2</sub> was 0.4 but it

was not statistically significant (p=0.814) (Table 2). There was a no correlation between the general knowledge scores at  $L_0$  and  $L_1$  [r = 0.163, n = 38, p = 0.328] but there was a correlation between the general knowledge scores at  $L_1$  and  $L_2$  [r = 0.688, n = 38, p = <0.001].

There was an increase in the proportion of participants who claimed to be familiar with different implant systems from Lo (15.8%) to L1 (57.8%) but there was a slight reduction at  $L_2$  (50%). For familiarity with implant design, the proportion increased from 13.2% at  $L_0$  to 50% at  $L_1$  and 57.9% at L<sub>2</sub>, for familiarity with implant sizes, the proportion increased from 13.2% at L₀ to 50% at L₁ and L<sub>2</sub>. And for familiarity with implant loading, the proportion increased from 13.1% at L₀ to 55.3% at  $L_1$  and 57.9% at  $L_2$  (P<0.001) (Table 3).

The proportion of respondents who were not at all satisfied with the level of implant education received decreased from 31.6% at Lo to 13.2% at L1 but slightly increased to 18.4% at L2 (p<0.001). Only a few respondents (5.3%) were not at all interested in implant dentistry at Lo and this proportion further reduced to 2.6% at  $L_1$  and  $L_2$  (p<0.001). Concerning their level of preparedness to practice implant dentistry, 39.5%, 10.5% and 15.8% felt not at all adequate at Lo, L1 and L2 respectively (p<0.001) (Table 4)

Among the respondents who claimed to have managed patients with missing teeth, the proportion who presented dental implants as a treatment option increased from 22.7% at  $L_{\text{o}}$  to 53.1% at  $L_{\text{1}}$  and 75% at  $L_{\text{2}}$ . The proportion of the respondents who felt dental implant is a more difficult treatment option when compared to other treatment options, among those who claimed to have managed patients with missing teeth, was 63.6%, 75% and 62.5% at  $L_{\text{o}}$ ,  $L_{\text{1}}$  and  $L_{\text{2}}$  respectively (Table 5).

## **DISCUSSION**

As implant dentistry gained dominance in developed parts of the world, it became very necessary to harmonize dental education on implant therapy and to ensure acceptable level of competence among both undergraduate and postgraduate dental students (Sanz & Saphira, 2009). A previous study emphasized the need to enhance undergraduates' knowledge regarding dental implants based on the incorrect and incomplete knowledge the study elicited among the studied dental students (Chandarana et al., 2018). Previous studies reported that majority of the studied undergraduate dental students felt the degree programme did not provide sufficient information about implant treatment procedures and would like more to be provided in the curriculum (Chaudhary et al., 2013; Sheth et al., 2017; Enabulele & Omo, 2018; Sharma et al., 2018). This study revealed incomplete general knowledge

on implant dentistry and not all the dental students were familiar with the various types of implant systems, sizes, designs and loading. These findings support the call for the review of the undergraduate curriculum on implant dentistry.

The respondents' predominant source of information of implant dentistry was didactic class lectures. This is different from what was reported in Kuwait (Al-Musawi et al., 2017) where the participants gathered dental implants information through media (33.9%), friends or social gatherings (24%), dental clinics (23.3%) and family (18.8%). It is likely that dental students receive didactic training from more than one relevant area of specialization in dentistry since those who teach or practice implantology must have undergone postgraduate training in form of certificate courses, postgraduate diploma, master's degree or specialist training in oral surgery, periodontics or prosthodontics (Association of Implantology, 2012). Majority of the respondents in this study however claimed to have received lectures on implant dentistry in periodontics.

Didactic teaching is expected to understanding of the basic concepts and achieve required learning results (Tubbs, 2014; Enabulele & Omo, 2018). The result of this study seems to suggest that although the general knowledge on implant increased after the first didactic teaching, the knowledge was not fully retained after 3 months. It has been suggested that knowledge gained may not be fully retained if the learner is not made to visualise and practicalize the knowledge gained and this may explain the pattern reported by this present study (Goins & Fisher, 2018). It should therefore be recommended that training on a technical area such as implant dentistry must include simulations and the use of audio-visuals. A previous study, which also identified some areas of deficiencies in undergraduate implant training, recommended revision of the undergraduate dental curricula to accommodate the practical aspect of implant dentistry (Chaudhary et al., 2013). The respondents' level of interest and preparedness to practice implant dentistry increased initially with didactic lectures and later decreased few months after. It is possible that more detailed private study on the part of the students revealed some more technicalities that made them become uncertain of their competence.

There was an increase in the proportion of the respondents who provided option of implant therapy, to patients who presented to the dental clinic for replacement of missing teeth, from the initial point to when they received didactic training

and 3 months after. This suggests that the more knowledgeable the dental students became in implant dentistry, the more likely they were to educate their patients and the more the number of persons who will be able to make informed decision about their treatment. This can be assumed because it was previously reported in another study that majority of the studied population could accept their dentist's advice for replacement of missing teeth with implant (Suprakash et al., 2013; Awooda et al., 2014; Kumar & Chauhan, 2015). However, despite the fact that more of the respondents, after didactic training, became more willing to prescribe implant therapy, majority still consider it a more difficult treatment option when compared with other options. This may be because the training they received did not include practical "hands-on" training. It is generally believed that any teaching practicalized becomes easier. Could we then conclude that the dental students in this study considered implant therapy a more difficult option because they had no practice?

#### CONCLUSION

The findings of this study suggest that the dental implant program which consisted of only didactic lectures is an effective method of knowledge acquisition in implant dentistry but does not translate to equal knowledge retention and students' level of preparedness with regards to plans for providing dental implant care Therefore, more is needed to improve dental implant training at the undergraduate level. Furthermore, there is need for continuous dental education on implant dentistry, with special emphasis on the practical aspects for dentists in developing countries such as Nigeria.
